### NVPERS Bill Tracking

#### **Assembly Bills**

**Assembly Bill 222 (BDR 23-752)** Makes changes to the computation of credit for service for certain members of the Public Employees' Retirement System.

**The Retirement Board took a position to oppose the language as written but allow staff to continue working with the sponsor on a possible amendment to allow a recommendation for a neutral position.**

**Assembly Bill 351 (BDR 23-688)** Establishes the Deferred Retirement Option Program for certain public employees.

**The Retirement Board took a position in opposition to this bill at their April 20, 2023, meeting.**

**Assembly Bill 400 (BDR 34-1088)** Revises various provisions relating to education. Section 79 of this bill authorizes the Governor to designate a position in any school district or charter school in this State for which there is a critical labor shortage, thereby enabling such a position to be filled by a retired employee without loss of retirement benefits.

**The Retirement Board took a position in opposition to section 79 of this bill at their April 20, 2023, meeting.**

## Senate Bills

---

**SB14 (BDR 41-259) Makes various changes related to gaming.**

**The Retirement Board took a position to oppose Section 10 of Senate Bill 14 as written and be neutral if the bill is amended to only provide a very limited re-employment exemption to the Gaming Commission members.**

**SB308 (BDR 23-1018) Revises provisions relating to educational personnel.**

**The Retirement Board took a position to oppose the language as written but with a possible neutral position with proposed amendment.**

**SB388 (BDR23-131) Revises provisions relating to certain public employees.**

Authorizing certain collective bargaining agreements entered into by the Executive Department of the State Government to contain certain provisions relating to the payment of contributions to the Public Employees' Retirement System; and providing other matters properly relating thereto.

**The Retirement Board took a position to oppose the language as written but with a possible neutral position with proposed amendment.**

**SB431 (BRD 18-1089) Revises provisions relating to governmental administration.**

**The Retirement Board took a position to oppose Section 3 of the bill as written but with a possible neutral position with proposed amendment.**

**SB434 (BDR 23-16) Revises provisions related to retirement. Revising provisions governing eligibility for membership in the Public Employees' Retirement System; revising provisions governing the options for service retirement allowances under the System; revising**

provisions relating to the granting of a divorce; revising provisions governing the disposition of certain pension or retirement benefits upon dissolution of marriage; and providing other matters properly relating thereto marriage; and providing other matters properly relating thereto
