POLICE & FIREFIGHTERS' RETIREMENT FUND ADVISORY COMMITTEE MEETING MINUTES

January 28, 2010

A. Mineral County

1. Fire Chief

On a motion by Chris Collins, seconded by Rich Tiran, the Committee voted 3 yeas and 0 nays with 1 abstention by Bill Loncar to recommend approved coverage for the Fire Chief position with Mineral County.

B. White Pine County Fire District

1. Fire District Chief

On a motion by Rich Tiran, seconded by John Chase, the Committee voted 3 yeas and 0 nays with 1 abstention by Bill Loncar to recommend approved coverage for the Fire District Chief position with White Pine County Fire District.

C. City of Henderson

1. Chief Marshal Alternative Sentencing

On a motion by Bill Loncar, seconded by John Chase, the Committee voted unanimously of those present to recommend promotional coverage for the Chief Marshal Alternative Sentencing position with the City of Henderson.

Tina Leiss presented an overview of the Police/Fire Committee and Process.

B. PFRFAC member terms

Tina Leiss explained that Senate Bill 427 (2009) changed Committee member terms from three years to four years and that at the January 2010 meeting the Retirement Board extended the current terms for the Committee members.

C. Staff Reports

Tina Leiss, Operations Officer, advised the Committee of the Interim Retirement and Benefits Committee meeting to be held on February 2, 2010. Ms. Leiss gave an overview of the actuarial valuation as of June 30, 2009. She stated that the Retirement Board held a hearing earlier this month regarding the proposed changes to the PERS policies. Ms. Leiss explained some of the changes and stated that a second hearing would be held at the February Retirement Board meeting. She stated that the Retirement Board was advised of plans to create three new programs: employer advisory council, employee advisory council, and retiree ambassador program.

Brian Snyder advised the Committee that the Liaison Officer Conference held in November 2009 was well attended. He stated that employers indicated the need for more individualized training and his staff will be scheduling workshops during the rest of this fiscal year. Mr. Snyder told the Committee that one of his staff, LaDonna Bennett, will be retiring as of February 2, 2010. She started August 8, 1974, and has only worked for PERS.
