She indicated that the majority of member statements have been sent out and that the division is in the process of performing Police/Fire reconciliations. She told the Committee that the new contribution rates would start July 1, 2015. She advised the Committee that the Division of Forestry had withdrawn the Helitack Supervisor position. Ms. Hellwinkel stated that in February she would be sending a notice requesting applications for the two Committee positions that expire June 30 of this year.
