January 31, 2017 Board Meeting

The Retirement Board meeting of the Public Employees' Retirement Board was called to order by Chairman Vincent at 9:10 a.m., on January 31, 2017, in the PERS' Board Room, 693 W. 1. <u>PUBLIC COMMENT</u>

Elaine Steiner stated that she has some concerns about what is going on. She indicated that she has attended the court proceedings and has a feeling that while we are attempting to protect our rights we have not really caught what NPRI is really after and she thinks there is a hidden agenda but does not know how to resolve it. She stated that they will support us as best they can and hopes that there can be a resolution to help them and protect them.

Terri Laird, Executive Director of RPEN, indicated that they represent close to 9,000 dues paying members of their organization. They want to pledge support for the Board's efforts to appeal this decision. She stated that RPEN filed a couple of amicus (friend of the Court) briefs when PERS faced a similar challenge with Reno Newspapers. They want to say on record that they are in support of PERS' efforts and will help in any way they can. She indicated that they are also very concerned about cyber crime because that group is vulnerable.
