# May 21, 2009 Board Meeting

The Retirement Board Meeting of the Public Employees' Retirement Board was called to order by Chairwoman Susan DeFrancesco at 8:15 a.m., May 21, 2009, in the PERS' Board Room, 693 West Nye Lane, Carson City. Members present: Susan DeFrancesco, Purisimo Hernandez, George Stevens, Mark Vincent, and Warren Wish. Members absent: David Kallas and Charles Silvestri.

#### I. DISABILITIES

- A. For the record Sue DeFrancesco disclosed that she was aware of Karen Stansfield-Paquette's situation and was familiar with Purisimo Hernandez's situation but did not feel this would keep her from voting. For the record Warren Wish and George Stevens disclosed they were familiar with Purisimo Hernandez's situation and did not feel that would keep them from voting. On motion of Warren Wish, the Retirement Board voted 4 yeas and 1 abstention to:

#### III. <u>BOARD</u>

- A. On motion of Mark Vincent, the Retirement Board voted unanimously of those present to approve the minutes of the Retirement Board's education session and Board meeting held April 14 and 15, 2009, as submitted. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.
- B. There were no recommended changes to the Retirement Board meeting dates.
- C. On motion of Purisimo Hernandez, the Retirement Board voted unanimously of those present to eliminate Board education in July 2009, move the July topics to another month, and hold a portion of the July Board meeting on the afternoon of Tuesday, July 14, 2009. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.

## IV. <u>ADMINISTRATION</u>

A. Staff reviewed the minutes and recommendations of the Police and Firefighters' Retirement Fund Advisory Committee meeting held April 23, 2009. On motion of Warren Wish, the Retirement Board voted unanimously of those present to approve the minutes of the Police and Firefighters' Retirement Fund Advisory Committee meeting held April 23, 2009, as submitted. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.

#### V. <u>LEGISLATION</u>

- A. Staff provided an update on the Bill Draft Request list for the 2009 Legislative Session.
- B. Staff reviewed Assembly Bill 92 which revises certain provisions governing the benefits of a retired justice or judge. After discussion, on motion of Purisimo Hernandez, the Retirement Board voted unanimously of those present to adopt a neutral position on Assembly Bill 92, as amended. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.
- C. Staff reviewed Assembly Bill 488. As amended, Assembly Bill 488 provides a reemployment exemption for positions designated as critical labor shortage and applies to all members of the System. After discussion, on motion of Mark Vincent, the Retirement Board voted unanimously of those present to adopt a neutral position on Assembly Bill 488, as amended. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.
- D. Staff reviewed Senate Bill 427 which revises provisions governing the Public Employees' Retirement System. After discussion, on motion of Warren Wish, the Retirement Board voted unanimously of those present to adopt a neutral position on Senate Bill 427. David Kallas, Charles Silvestri, and George Stevens were not present for the vote on this agenda item.
- E. The request of a Board member regarding NRS 286.160 and NRS 286.170 was deferred.
