POLICE & FIREFIGHTERS' RETIREMENT FUND ADVISORY COMMITTEE MEETING MINUTES

August 27, 2009

The meeting was called to order at 10:00 a.m. at the Public Employees' Retirement System Office, 693 West Nye Lane, Carson City, Nevada. Members present: Bill Loncar, Rich Tiran, Rusty McAllister, John Chase, and Chris Collins.

- A. On a motion by Rusty McAllister, seconded by Rich Tiran, the Committee voted unanimously to approve the Minutes of the PFRFAC meeting held April 23, 2009.

B. Sierra Fire Protection District

1. Fire Captain—Prevention

D. Elko County

1. Sheriff's Captain

A. Ratification – Title changes (Action)

On a motion by Bill Loncar, seconded by John Chase, the Committee voted unanimously to recommend approval of the following position title changes with no change in the police/fire coverage status as follows:

- 1. Storey County—Undersheriff to Assistant Sheriff
- 2. Douglas County, Justice Court/District Attorney—Special Investigator to Investigator Specialist I
- B. Review of two Superintendent positions with the State of Nevada, Division of Child and Family Services, Caliente Youth Center and the Youth Parole Bureau, regarding Police/Fire coverage (Action)

On a motion by Bill Loncar, seconded by Rich Tiran, the Committee voted unanimously to recommend that coverage in the Police and Firefighters' Retirement Fund be removed for the Superintendent of the Caliente Youth Center and the Superintendent of the Nevada Youth Training Center.

C. Investment Presentation

Ken Lambert, Investment Officer, presented PERS' Fiscal Year 2009 Performance Review to the Committee.

D. Education – Disaster Recovery Review

Tina Leiss, Brian Snyder, and Shell Lemburg presented an overview of Disaster Recovery.

E. 2009 Legislative Session Status Report

Tina Leiss, Operations Officer, discussed the six bills affecting Chapters 286 or 1A (the Judicial Retirement System) which became law as a result of the 2009 legislative session.

F. Staff Reports

Tina Leiss, Operations Officer, talked to the Committee about the actuarial valuation. Ms. Leiss stated that a new Chairman and Vice Chairman were elected for the Retirement Board. George Stevens is the new Chairman and Mark Vincent is the Vice Chairman. Ms. Leiss informed the Committee that the SEC has proposed pay-to-play rules. She also stated that the SEC has no jurisdiction over public pension systems. They do have jurisdiction over investment managers. Ms. Leiss told the Committee about changes to GASB accounting standards regarding discounting rates. The new standards will not be set until 2011. Ms. Leiss stated that she attended the NASRA conference in Savannah, Georgia.

Brian Snyder advised the Committee that his staff is gearing up to send member statements. He also stated that a different delivery system may be used such as posting the statements on the website or emailing them to individual members. Mr. Snyder asked the Committee if they were receiving member newsletters from their employers and whether the employers were distributing them through email or paper copy.
