POLICE AND FIREFIGHTERS' RETIREMENT FUND ADVISORY COMMITTEE MEETING MINUTES

October 16, 2014

A. Clark County District Attorney

1. Investigator II

Craig Fabert was present and answered questions from the Committee. After discussion, on a motion by Brian Allen, seconded by Bill Ames, the Committee voted unanimously to recommend promotional coverage for the Investigator II position with the Clark County District Attorney.

B. Elko County

1. Fire District – Firefighter I

After discussion, on a motion by Rich Tiran, seconded by Brian Wolfgram, the Committee voted unanimously to recommend approved coverage for the Fire District – Firefighter I position with Elko County.

2. Fire District – Firefighter II

3. Fire District Division Chief – Prevention
