# January 17, 2019 Board Meeting

The Retirement Board meeting of the Public Employees' Retirement Board was called to order by Chair Ross at 12:12 p.m., on January 17, 2019, in the PERS' Board Room, 5740 S. Eastern Avenue, Suite 120, Las Vegas. Members present: Timothy Ross, Scott Gorgon, Lee-Ann Easton (by telephone), Dawn Huckaby, Yolanda King, and Brian Wallace. Members absent: None.

# 1. PUBLIC COMMENT

Kent Ervin, representing the Nevada Faculty Alliance, the statewide independent association of faculty at all eight NSHE institutions, addressed the Retirement Board regarding Agenda Item 5, Legislation Update. He stated that the Nevada Faculty Alliance will be opposed to Assembly Bill 75 and Senate Bill 83. Mr. Ervin encouraged the Board to take appropriate action. Mr. Ervin said that AB 75 is a repeat of an old story that would destabilize PERS and have serious consequences as far as the finances of the System. SB 83 would dilute and make more inefficient the operation of the PERS Board. They are opposing both of those bills. He thanked the Board.

Cameron Wagner with the Washoe County Sheriff Deputies Association and PORAN thanked the Retirement Board for their effort and energy to protect his retirement and the retirement income of all public employees and retirees in the state of Nevada. He thanked the Board and Executive Staff for the efforts to control, navigate, and ensure the Public Employees' Retirement System fund remains healthy throughout the dramatic swings in the economy and different economic factors that have taken place. He asked that the Board and Executive Staff be faithful stewards of his personal information. He stated that he serves the public as a public employee but is a private individual and his personal information should not be thrown to the gutters of the internet. He chose to pursue his career as a public servant, but he also chooses to keep his family safe. Public employees, especially first responders, have a difficult task to make sure they come home safe every day; they should not lose sleep and fear for safety that their information is available for everybody. He hopes that during the upcoming legislative session protections for his personal information will be bolstered and strengthened by possibly amending state laws. He then extended a special thank you to Executive Staff, especially Tina and Cheryl, for their continued education and efforts to educate public employees and retirees but most importantly educating the current and aspiring political leaders. Mr. Wagner stated that he has seen firsthand how the minds and jaded opinions have changed in these public leaders and political leaders through these information sessions. Some of these political leaders are relying on rumors and false information for their assumptions. Tina and Cheryl present the facts and set the record straight. He then thanked the Board for their time.
