Ms. Hellwinkel informed the Committee that she already has three applications ready for the next meeting.

Tina Leiss, Executive Officer, announced that the Board has hired a second opinion actuary review firm. In our October Board meeting, the actuary will review our experience studies and our valuation to make sure they agree with everything. Our funding valuation, which is a rate setting year, is due to the Board in November. At the November Board meeting, we should have that valuation, and that will set the rates for

the upcoming year. Ms. Leiss also announced that Tim Ross has been reappointed to the Retirement Board. The new Board Chair is Kathy Ong, and the new Vice Chair is Tim Ross.
