Nye Lane, Carson City. Members present: Timothy Ross, Yolanda King (by videoconference), Dawn Huckaby, Mark Stevens and Brian Wallace. Members absent: Todd Ingalsbee.

July 16, 2020 Board Meeting

The Retirement Board meeting of the Public Employees' Retirement Board was called to order by Chair Ross at 10:03 a.m., on July 16, 2020, in the PERS' Board Room, 693 W. Nye Lane, Carson City. Members present: Timothy Ross, Yolanda King (by videoconference), Dawn Huckaby, Todd Ingalsbee (by telephone), Mark Stevens, and Brian Wallace. Members absent: None.

1. <u>PUBLIC COMMENT</u>

There were no public comments offered.

2. <u>DISABILITIES</u>

2.1 For the record, Yolanda King stated that Applicant Nos. 1, 7, 16, and 23 work or worked for the same employer as herself but she did not feel that it would impair her vote.

On motion of Brian Wallace, the Retirement Board voted unanimously to:

- 1. Approve permanent and total disability retirements for Applicant Nos. 1-14, as recommended by staff for the month of July 2020.
- 2. Approve reemployment requests by disability recipients, Applicant Nos. 15-23, as recommended by staff for the month of July 2020.
- 3. Deny reemployment requests for disability recipients, Applicant Nos. 24-25, as recommended by staff for the month of July 2020.

3. **INVESTMENTS**

- 3.1 Staff and Julia Bonafede of Jobs Peak Advisors provided an update on Private Markets. There was no action taken on this item.
- 3.2 There were no recommended changes to the Interim Investment Directives for the PERS', Legislators', and Judicial funds.

4. <u>BOARD</u>

- 4.1 On motion of Brian Wallace, the Retirement Board voted unanimously to elect Tim Ross, Chair, and Yolanda King, Vice Chair, of the Retirement Board for fiscal year 2021.
- 4.2 Staff provided the PERS' executive management review and plan to the Board. Staff presented highlights from the previous fiscal year in seven different categories:

Staff also mentioned areas that the executive staff will be focusing on for review in the upcoming fiscal year. On motion of Brian Wallace, the Retirement Board voted unanimously to accept the Executive Management Review and Plan, as submitted.

- 4.6 On motion of Tim Ross, the Retirement Board voted unanimously to approve the proposed Retirement Board meeting dates for January 2021 through June 2021, as submitted.
- 4.7 There were no recommended changes to the Retirement Board meeting dates for the rest of the calendar year.
- 4.8 There were no recommended changes to the Retirement Board Education Curriculum calendar.

On motion of Yolanda King, the Retirement Board voted unanimously to approve the appointment of Scott Nicholas to complete the term previously held on the Police and Firefighters' Retirement Fund Advisory Committee.
