Tina Leiss, Executive Officer, presented an overview of the above subject. After discussion, on a motion by Scott Vivier, seconded by Bill Gardner, the Committee voted unanimously of those present (Cameron Wagner was not present for this vote) to recommend the Retirement Board revise the Police & Firefighter's Retirement Fund Advisory Committee Policy to add a management member and define the employee and management positions by approved and promotional coverage. The Committee requested staff prepare language to submit to the Retirement Board and that current Committee members not be affected.
