May 20, 2021 Board Meeting

The Retirement Board meeting of the Public Employees' Retirement Board was called to order by Chair Ross at 10:18 a.m., on May 20, 2021, at 693 W. Nye Lane, Carson City. Members present: Timothy Ross, Yolanda King (by teleconference), Dawn Huckaby (by teleconference), Mark Stevens, Brian Wallace, and Norma Santoyo (by teleconference). Members absent: Todd Ingalsbee.

1. <u>PUBLIC COMMENT</u>

There were no public comments offered.

2. <u>DISABILITIES</u>

2.1 For the record, Yolanda King stated that Applicant Nos. 2, 22 works or worked for the same employer as herself, but she did not feel that would impair her vote. Tim Ross stated that Applicant No. 12 works or worked for the same employer as himself, but he did not feel that would impair his vote. Norma Santoyo state that Applicant Nos. 19,20 works or worked for the same employer as herself, but she did not feel that would impair her vote.

- 3.1 Staff and Julia Bonafede of Jobs Peak Advisors presented the 3rd quarter fiscal year 2021 performance update for the PERS', Legislators', and Judicial funds. There was no action taken on this item.
- 3.2 There were no recommended changes to the Interim Investment Directives for the PERS', Legislators', and Judicial funds.

- 4.3 On motion of Mark Stevens, the Retirement Board voted unanimously of those present (Norma Santoyo and Todd Ingalsbee were not present) to approve the minutes of the Retirement Board Education Session and Retirement Board meeting held April 15, 2021, as submitted.
- 4.4 On motion of Tim Ross, the Retirement Board voted unanimously of those present (Norma Santoyo and Todd Ingalsbee were not present) to approve the changes to the Retirement Board meeting dates, as submitted.
- 4.5 On motion of Tim Ross, the Retirement Board voted unanimously of those present (Todd Ingalsbee was not present) to approve the changes to the Retirement Board Education Curriculum Calendar, as submitted.
