July 21, 2022 Education Session

The Retirement Board Education Session of the Public Employees' Retirement Board meeting was called to order by Chair Ross at 9:10 a.m., July 21, 2022, in the PERS' Board Room, 693 W. Nye Lane, Carson City. Members present: Timothy Ross, Yolanda King, Todd Ingalsbee, Norma Santoyo, and Mark Stevens. Members absent: Dawn Huckaby and Brian Wallace.

1. <u>PUBLIC COMMENT</u>

Jon Klassen, a retiree from Clark County Fire Department, made comment about the current retiree payment schedule. He mentioned that he did an informal poll with 20 people asking if they would like to keep one check per month or receive multiple payments per month. He mentioned that there was a strong interest in being paid multiple times and was wondering if he could mention it to the Retirement Board for possible review.

July 21, 2022 Board Meeting

The Retirement Board meeting of the Public Employees' Retirement Board was called to order by Chair Ross at 10:26 a.m., on July 21, 2022, in the PERS' Board Room, 693 W. Nye Lane, Carson City. Members present: Timothy Ross, Yolanda King, Todd Ingalsbee, Norma Santoyo, and Mark Stevens. Members absent: Dawn Huckabee and Brian Wallace.

1. <u>PUBLIC COMMENT</u>

There were no public comments offered.

2. <u>DISABILITIES</u>

2.1 For the record, Yolanda King stated that Applicant Nos. 11, 15, 16, and 17 work or worked for the same employer as herself but she did not feel that it would impair her vote. Norma Santoyo stated that Applicant No. 9 work or worked for the same employer as herself, but she did not feel that it would impair her vote.

On motion of Tim Ross, the Retirement Board voted unanimously of those present to:

- 1. Approve permanent and total disability retirements for Applicant Nos. 1-17, as recommended by staff for the month of July 2022.
- 2. Approve reemployment requests by disability recipients, Applicant Nos. 18-27, as recommended by staff for the month of July 2022.

3. <u>INVESTMENTS</u>

- 3.1 Staff provided an overview of Private Markets Reporting Guidelines. On motion of Norma Santoyo, the Retirement Board voted unanimously of those present to accept the Private Markets Reporting Guidelines, as submitted.
- 3.2 There were no recommended changes to the Interim Investment Directives for the PERS', Legislators', and Judicial funds.

- 4.1 On motion of Norma Santoyo, the Retirement Board voted unanimously of those present to elect Tim Ross, Chair, and Yolanda King, Vice Chair, of the Retirement Board for fiscal year 2023.
- 4.2 On motion of Mark Stevens, the Retirement Board voted unanimously of those present to approve the minutes of the Retirement Board Education Session and Retirement Board meeting held June 16, 2022, as submitted.
- 4.3 On motion of Norma Santoyo, the Retirement Board voted unanimously of those present to approve the proposed Retirement Board meeting dates for January 2023 through June 2023, as submitted.
- 4.4 There were no recommended changes to the Retirement Board meeting dates for the rest of the calendar year.
- 4.5 Yolanda King asked if an overview of the current funding policies could be added to the Education Curriculum Calendar for August 2022. On motion of Tim Ross, the Retirement Board voted unanimously of those present to approve the Education Curriculum for August 2022.

- 5.3 On motion of Mark Stevens, the Retirement Board voted unanimously of those present to approve the Judicial Retirement System Biennial Budget for Fiscal Years 2024-2025, as submitted.
