On motion of Todd Ingalsbee, the Retirement Board unanimously of those present (Dawn Huckaby was not present for this vote) voted to:

- 1. Approve permanent and total disability retirements for Applicant Nos. 1-15, as recommended by staff for the month of February 2023
- 2. Approve reemployment requests by disability recipients, Applicant Nos. 16-22, as recommended by staff for the month of February 2023
- 3. Deny reemployment requests by disability recipients, Applicant No. 23, as recommended by staff for the month of February 2023

3. INVESTMENTS

- 3.1 Staff and Julia Bonafede of Jobs Peak Advisors presented the 2nd quarter fiscal year 2023 performance update for the PERS', Legislators', and Judicial funds. There was no action taken on this item.
- 3.2 There were no recommended changes to the Interim Investment Directives for the PERS', Legislators', and Judicial funds.
